### **How We Use Personal Data**

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect when the user performs certain functions may be used for the following purposes:

### **Who We Share Personal Data With**

#### **Employees**

### **How Long We Store Personal Data**

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

### **How We Protect Your Personal Data**

All information we collect about you is stored securely in strictest confidence and is accessible only to our employees who are bound by confidentiality agreements. In any event that an employee breaches a confidentiality agreement, their employment will be terminated and potentially be sued.
